

LIVE ANIMAL DISPLAY SPACE FOR LIVESTOCK (OTHER THAN BEEF CATTLE)

Application Procedure

Priority will be given to associations of species other than beef cattle. Remaining space will be accepted on a first come, first served basis. **Complete and return entry application, accompanied by full payment, to CWA no later than October 1.**

Display space will be sold to a maximum of 30'. **GST applies on all fees.**

All animals on display must comply with the General Health Regulations of Agribition and where applicable, animals must come from T.B. and Brucellosis accredited herds as well as be accompanied by a valid Herd Transportation Permit. The display of cervidae species **will not** be allowed in 2010.

Location

The Ag-Ex Pavilion will be the home of this Livestock Display area. The exhibit area is located on the main route connecting the Brandt Centre (main equine show arena) to the other livestock barns and captures over 85% of Agribition on ground traffic.

Display Rules and Regulations

1. No exhibit shall block the view of any other exhibit or exceed space allotted. Solid side panels of display must not exceed 4' feet in height or 10 feet in length.
2. Signage, videos, etc. are permitted **to be displayed within the confines of the allocated exhibit space.**
3. Promotional materials that could have an adverse effect on the facilities or livestock must not be handed out to the public, ie. balloons, stickers, yardsticks.
4. The distribution of printed information, brochures, poster, and other printed handouts is permitted from your allocated booth space. Products such as fleeces, fibre, etc. may be displayed within your booth space.
Selling of items and cooking of produce is **not** permitted. Free samples of pre-packaged meat/produce only are allowed for distribution. This display area is provided primarily for the promotion and marketing of livestock genetics, space is available in other locations of Agribition specifically for the promotion and merchandising of by-products related to your industry.
5. Sale and Farm signs/posters are permitted to be displayed within the breeders display area and are the responsibility of the individual breeder. Farm signs must fit within the dimensions of the breeders' designated display space. Breeders, who want to display posters outside their designated stall space: At Agribition '09, there is the opportunity for Breeders to display posters outside of their designated stall area. Key display areas have been chosen throughout the grounds. Each breed operation poster is restricted to a maximum of 11"x17" in size. Only posters/signs developed for the sole purpose of promoting/selling livestock genetics will be permitted. Posters/signs found to be distasteful (as determined by Agribition) will be removed. Delivery of Display Posters will be accepted at the Show & Sale Office until Sunday, November 21 - 6:00 pm. No more than 5 posters per Operation please.

Operation of Area

Set-Up: Animals must be in exhibit area and in place 8:00 a.m., Monday, November 21.

Operation: 8:00 a.m. to 6:00 p.m. daily.

Release Time: 6:00 p.m., Saturday November 26.
